At DigiQ, we are committed to protecting your privacy and ensuring that your personal data is handled in a safe and responsible manner. This Privacy Policy outlines the types of information we collect, how we use it, and the steps we take to safeguard it in accordance with the General Data Protection Regulation (GDPR).

1. Data Collection and Processing

When you use DigiQ, we collect and store certain information automatically. This includes:

- Date and time of access
- IP address of the accessing device

- HTTP status code
- Amount of data transferred
- Referring URL (if applicable)
- Browser type and version
- Operating system

This data is collected to facilitate the use of our website, ensure system security, manage our network infrastructure, and optimize our online offerings. We only analyze IP addresses in case of attacks on our network infrastructure.

Personal data you provide during communication with DigiQ will only be used for specified purposes and will not be shared with third parties without your consent. However, please note that data transmission over the Internet (e.g., email communication) can have security vulnerabilities, and complete protection against unauthorized access by third parties is not possible.
